LP Gas Repairmen's Test

SECTION I:

- 1. A current edition of Handbook 44 must be available at all times.
- 2. The Commissioner of Agriculture is authorized to establish Rules and Regulations governing commercial measuring devices
- 3. After a device has been rejected, the serviceman is required to bring the device into maintenance tolerance.
- 4. When a rejected device is repaired, a "Service Certification" form and copy of calibration must be sent to the Fuel and Measures Division, Department of Agriculture.
- 5. Technical requirements for commercial weighting and measuring devices are published in the NIST Handbook 44, current edition.
- 6. Before making repairs to a rejected device, the Repairman must make an "as is" run.
- 7. When a device is found to be inaccurate, an inspector may tie the device down to prevent further usage until repairs are made.
- 8. All liquefied petroleum liquid measuring devices, for both wholesale and retail service, shall be equipped to deliver only temperature compensated volumes.
- 9. It is illegal to break a seal or remove a seal without notifying the Department of Agriculture.
- 10. All written invoices shall be based on temperature compensated measurements.
- 11. The Commissioner of Agriculture may suspend or revoke a Serviceman's license for good cause.
